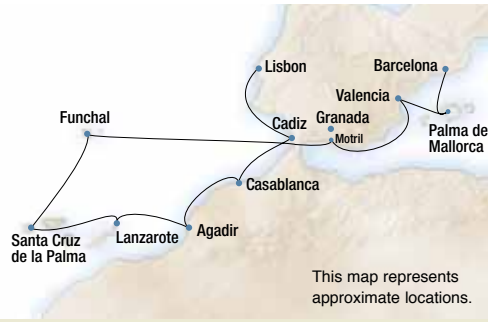

PALMA DE MALLORCA, SPAIN

Explore this beautiful island beginning with the magnificent Cathedral and Bellver Castle. See the windmills and an impressive manor house in the verdant countryside. Discover the amazing natural wonders in the Drach Caves. And for romance, visit the former Carthusian Monastery in Valdemosa where George Sand and Chopin spent a winter.

VALENCIA, SPAIN

Spain's third largest city is home to the City of Arts and Sciences, which includes an impressive collection of attractions. Visit the Gothic city of Requena featuring perfectly preserved, 100-year-old wine cellars. GRANADA (MOTRIL), SPAIN

FUNCHAL (MADEIRA), PORTUGAL

Breathtaking vistas await throughout this beautiful island. Take a cable car up to Monte for spectacular views of the Botanical Gardens and the charming town. Drive along the coast to a village where Winston Churchill painted seascapes or out to the stunning cliffs of Cabo Girão and enjoy a visit to a quaint fishing village.

SANTA CRUZ DE LA PALMA (CANARY ISLANDS), SPAIN
